## ENTERPRISE

- **Chief Technology Officer (CTO):** Responsible for overseeing the technological infrastructure and strategy of the organisation
- **Chief Information Officer (CIO):** Manages the information technology strategy and implementation within the enterprise
- **Blockchain Architect/Developer:** Professionals involved in designing and building blockchain solutions for the enterprise
- **Chief Supply Chain Officer (CSCO):** Relevant as we will be discussing blockchain applications in supply chain management
- **Chief Financial Officer (CFO):** Concerned with the financial implications and benefits of implementing blockchain technology
- **Chief Data Officer/Information Security Officer:** Responsible for ensuring the security of data and information within the enterprise
- **Chief Innovation Officer:** Focuses on identifying and implementing innovative technologies, including blockchain, within the organisation
- **Smart Contracts Developer:** Individuals involved in creating and deploying smart contracts on blockchain platforms
- **Governance/Regulatory/Compliance Officers:** Ensures that the enterprise's use of blockchain technology complies with relevant regulations and legal frameworks
- **IT and Infrastructure Managers:** Professionals overseeing the IT infrastructure required for blockchain implementations and interoperability

## INVESTORS AND INVESTMENT MANAGEMENT

- **Investment Managers:** Professionals responsible for managing investment portfolios that may include blockchain and digital assets
- **Venture Capitalists:** Investors seeking opportunities to fund promising blockchain projects



## GOVERNMENT

- **Chief Information Officer (CIO):** In government agencies, a CIO oversees technology strategies and implementations
- **Chief Data Officer (CDO):** Manages data-related strategies, including blockchain applications in government
- **Policy Maker/Regulator:** Officials responsible for formulating regulations and policies related to blockchain technology
- **Technology Director:** Responsible for the overall technology infrastructure and strategy within government agencies
- **Cybersecurity Officer:** Focuses on ensuring the security of government data and information, including blockchain-related systems
- **Digital Transformation Officer/Head of Digital Transformation:** Oversees the digital transformation initiatives within government organisations
- **Finance Director:** Concerned with the financial aspects and budgeting related to the implementation of blockchain solutions in government
- **Government Officials:** Representatives from government agencies and departments will attend to explore the potential use of blockchain for enhancing public services, improving transparency, and reducing fraud

## TECHNOLOGY BUILDERS AND SERVICE PROVIDERS

- **Blockchain Developers:** Developers specialising in blockchain technologies, including smart contracts and decentralised applications (DApps), will attend to stay updated on the latest developments
- **Blockchain Architect:** Involved in designing the overall structure and framework of blockchain systems
- **Blockchain Consultant:** Provides advice and guidance to businesses on how to implement and leverage blockchain technology
- **Blockchain Project Manager:** Manages projects related to the development and implementation of blockchain solutions
- **Blockchain Legal Consultant:** Specialised in the legal aspects of blockchain, including regulations and contracts
- **Blockchain Entrepreneurs/Start-up Founders:** People leading or involved in startups or incubators focused on blockchain technology

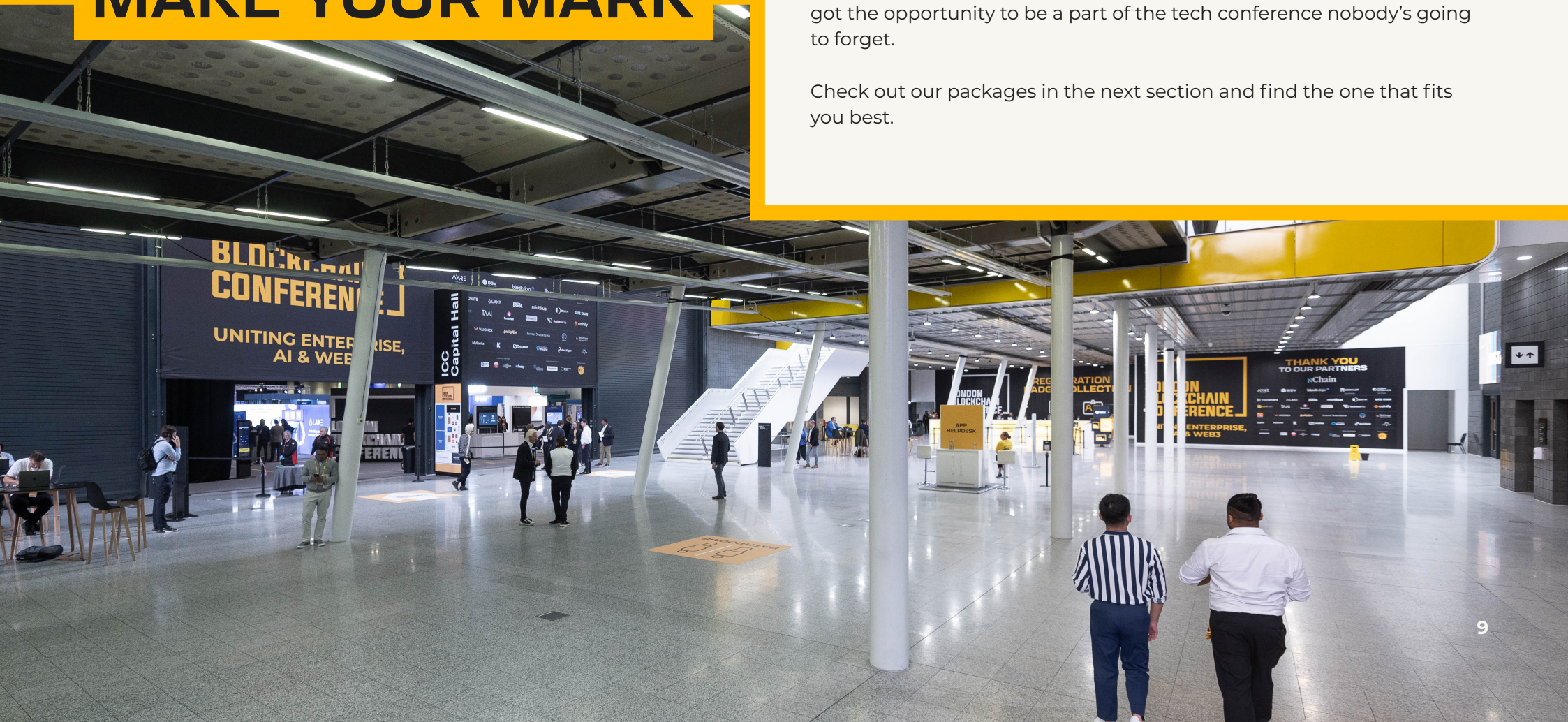
